Rapp. Board members in attendance, Treasurer T. Baylis, Clerk L. Blight, Trustee B. Maksimchuk and Trustee Cornell. Absent was D. Malloch Zoning Administrator.

APPROVAL OF THE MARCH 20, 2023 REGULAR BOARD MEETING MINUTES: A copy of The March 20, 2023 meeting minutes was email before tonight's meeting to each board member for their review. Trustee Cornell moved to accept the March 20, 2023 regular meeting minutes as written. Support was given.

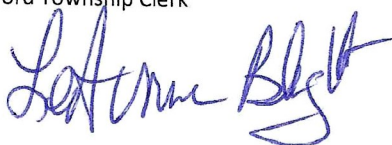
