HOMER FIRE BOARD REPORT: By Supervisor Rapp: The Home Fire Board wants us to invoice Consumers Energy for the nine runs for wires down that took place because of the winter storms.

MARENGO FIRE DEPARTMENT REPORT: Chief Blight: 8 runs in the last 30 days.

MARSHALL FIREFIGHTERS' AMBULANCE REPORT: By Trustee Cornell: Language approved for the millage renewal for the August election. Website was updated. And 9 runs in January with 3 in February.

ZONING ADMINISTRATOR REPORT: D. Malloch: Building permit at 6750 23 ½ mile road-Barton Farms. And informed the Board that the Building Inspector is resigning.

CODE ENFORCEMENT REPORT: D. Malloch: No report.

PLANNING COMMISSION: By M. Frohm, The Planning Commission has finished a review of the ordinance book, grammatical errors found and corrected. And presented a copy to the Board for their review.

Treasurer Baylis handed out information on a Special Assessment for the home owners on Orchard Drive. And asked that the Board read over the information.


Having no further business, Treasurer Baylis motioned that we adjourn @ 8:05 pm.
