

# ECKFORD TOWNSHIP MONTHLY MEETING DECEMBER 20, 2021

A monthly meeting of Eckford Township Board was held on Monday December 20, 2021 at the Eckford Township Hall. A quorum being present the meeting continued. The meeting was called to order at 7:00 pm by Supervisor B. Rapp. Other board members in attendance, Treasurer T. Baylis, Clerk L. Blight, Trustee W. Cornell, and Zoning Administrator D. Malloch.
