WHEREAS, Michigan Electric Transmission Company, LLC, ("METC") ITC Holding Corporation, has provided Eckford Township Board a proposed major transmission line known as the Helix to Hiple Project (the "Construction Plan"), and

WHEREAS, the line will travel a primary route through Eckford Township, Sections 31, 30, 19, 18, 07, 06, 05, and 04.

WHEREAS, the alternate route will travel through Eckford Township, Sections 35, 26, 23, 14, 11, 02, 01, and

WHEREAS, Eckford Township Board witnessed community voices in strong opposition to this Construction Plan at a recent monthly board meeting, October 16, 2023, and


NOW, THEREFORE, BE IT RESOLVED, that Eckford Township Board agrees with the community opposition to this primary and alternate routes of Construction Plan, and advises an entirely different plan to follow the Interstate Highways.


The foregoing RESOLUTION, was offered by board member Trustee Coenell and seconded by board member Trustee Maksimchuk. Upon roll call vote:

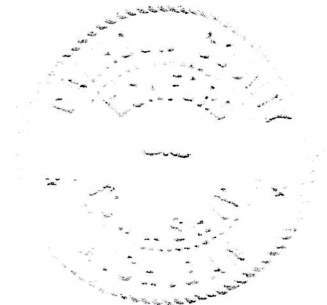

- 4-19 Mile road spot pave & Chip & Seal to new pavement
- 5-B Drive between 22- & 23-mile road till out of money

Motion was made by Treasurer Baylis to submit the above road projects. Support was given by Trustee Maksimchuk. Vote taken all in FAVOR.
