MARENGO FIRE:

Chief Blight dropped off the Marengo report before the meeting and did not stay due to COVID-19 gathering restriction. 2 runs in Eckford Township EMS call 9890 22 Mile road, Athol Hazen and EMS call 21357 D Drive South, Lansing Powers.

MARSHALL AMBULANCE AUTHORITY:

To date all ambulance personnel are healthy. To date we have a \$100,000 loss of revenue due to the Covid-19 crisis. Lease agreement with Tekonsha signed. They would like to refurbish another rig within the next year. Budget meeting in May. Eckford runs to date 8 in February, 9 in March. Overall, down 96 calls for the year.

(Quickbooks). The two favorite choices that the Clerk & Treasurer found are BS&A Software and payroll at a cost of \$23,000 and Redwing Center Point Software and payroll at a cost of \$3,540. After much discussion a motion was made by Supervisor Rapp to purchase the Redwing Center Point Software and payroll. Support by given by Trustee Cornell. All in favor. MOTION CARRIED.

At our May meeting we will review the 20-21 budget. Our budget hearing will be June 22, @ 7 pm before the regular monthly meeting.

Authorized Subdivision Agreement with Calhoun County. This agreement is for the Assessor Pictometry Program we purchase for the Assessor from Calhoun County.
